

The State Migration Service of Ukraine, its territorial bodies and subdivisions, as well as any competent authorities, institutions, organizations of Ukraine (in internal affairs bodies, border authorities, customs authorities, administrative service centers, etc.) on issues related to registration , prolongation of validity and obtaining a temporary residence permit issued in Ukraine to me; on issues related to the return of a temporary residence permit issued in Ukraine to me in the issuing and cancellation body marks on issuance of the certificate in the passport document, if necessary; on issues related to registration / withdrawal of registration of my place of residence at any address in Ukraine; on issues related to the registration of an administrative offense protocol and payment of a fine for late registration / removal from registration of a place of residence.
