Official attorney: As per power of attorney no. dated Jan. 7, 2003 from Ottawa, Iranian embassy and approval of Ministry of Foreign Affairs under no. dated Feb. 3, 2003, Ms. , daughter of Sirous, ID card no. 13488 issued in Tehran, a housewife acted as attorney of wife.

Type of Divorce: Revocable, first turn (for the first time).

DIVORCE DESCRIPTION:

The husband approached to the notary public repeatedly, necessary advices didn't have any result and he insisted on divorce. Upon sending notice No. 314 dated Apr.27.1986 and notification to the wife, the wife approached to this office on May 03, and didn't agree to sign the bill, having acknowledged that she was not pregnant. According to judgment No. dated Jan.07. issued by Bench 106 of Tehran Public Court and judgment No. dated Apr.20.1986 issued by Court of Appeal, all marriage portion as prescribed in marriage certificate No. dated Dec.22.1976 issued by Marriage Registry Office No.4 of Bakhtaran remains valid and the wife shall receive the same through execution. The husband paid the amount of Rls.20,000 as the first instalment of alimony of period and undertook to pay the remaining at the same amount per month. Regarding custody of children, the husband undertook to act the same as prescribed by the judgment. Having established the authenticity of divorce conditions, the divorce formula was pronounced at the presence of just witnesses. Signed.

The witnesses, Mr. , as two just men, heard the divorce formula. Signed.

On Nov.20.1988 the husband inquired from Notary Public's Office No. 36 of Karaj and received reply. Signed. Mr appeared in this office on Jan.01. and paid the amount of Rls.1,000,000 as for marriage portion and also amount of Rls.1,000,000 as for fair wage of the wife through a check No. 053356. Signed. On Jan.09. the wife approached to this office and received the said amount of Rls.2,000,000 from this office as for alimony, fair wage and marriage portion prescribed in certificate No. 5558 by Marriage Registry Office No.4 of Bakhtaran.
